## Wong Hock Boon Bursary

The late Emeritus Professor Wong Hock Boon had been dubbed as one of the founding fathers of modern medicine in Singapore, being the man behind landmark contributions in improving the health of children in Singapore and the world. ### Bursary value

The bursary is valued at \$5,000 per academic year.

### General terms and conditions

- The bursary is bond-free.
- The bursary is tenable for one academic year (currently AY2017/2018). A fresh application is required each academic year.
- The bursary will help defray some costs of tuition fees, accommodation fees and meal costs or the fees and costs of participating in an overseas exchange. Without prior approval from the Selection Committee/Office of the Provost, recipients may not concurrently hold any other bursary, scholarship or free aid for the same academic year. If you are offered a bursary/scholarship by both the OFA/Faculty and UTown, you will be informed if you are allowed to hold both awards concurrently.
